Mumbai : Ahmedabad-based, Sanstar Limited has garnered Rs.153 crores from anchor investors ahead of its initial public offering that opens for public subscription on Friday, July 19, 2024. The Company informed that it allocated 1,61,10,000 equity shares at Rs. 95 per share on Thursday, July 18, 2024, to anchor investors.

The diversified anchor book of Sanstar Limited comprises 13 anchors including global financial institutions, domestic mutual funds, large insurance & NBFC treasuries, AIFs and foreign portfolio institutions. The institutions who participated in the anchor are the following:

Sanstar Limited is one of the major manufacturers of plant-based speciality products and ingredient solutions in India for food, animal nutrition and other industrial applications. The products are used in custard, desserts, sauces, instant foods, tablets, baked foods, the confectioneries, pastas, soups and mayonnaise, in cream fillings, gravies, tomato ketchup, creams, dairy desserts, in confectionary, candies,

syrups, ready to eat sweets, bakery and so on. Sanstar products also find applications in personal care items, pharmaceuticals, nutrients, textiles and even biodegradable packaging materials amongst others. The Company also provides certified organic starch.

Sanstar exports to over 49 countries across Asia, Americas, Europe and Oceania, Middle East and Africa and derives more than 35% of the revenue from exports. During FY 2024, on a Consolidated basis, the Company generated ~1,067 crores of revenue, ~98 cores of EBITDA and ~67 crores of Profit After Tax (PAT) while ROE and ROCE were ~31% and 25% respectively. Revenue, EBITDA and PAT have grown at a CAGR of ~45%, ~57% and ~105% respectively during FY22-FY24, on a consolidated basis.

Sanstar operates two manufacturing facilities covering a total area of 10.68 million square feet (approximately 245 acres) situated in Dhule, Maharashtra, and Kutch, Gujarat. Notably, the Kutch facility of the Company is registered with United States Food and Drug Administration (USFDA). These facilities collectively boast an installed capacity of 3,63,000 tons per annum (1,100 tons per day). The Company ranks amongst largest manufacturers of maize-based speciality products and ingredient solutions in India (Source: Company Commissioned Frost & Sullivan Report, dated May 18, 2024). The Company has a bio-gas plant with an installed capacity of 1.56 megawatt to generate electricity from plant waste and utilize it as a renewable energy source and an installed solar capacity to generate electricity. To tap the next phase of the growth, the Company is in the process of expanding the capacity at Dhule facility on the existing land which is expected to increase 1,000 tons per day in capacity.

Chandipura Virus Kills 4-Year-Old In Gujarat, 14 More Deaths Suspected

New Delhi: The Chandipura virus has killed a four-year-old girl in Gujarat, a health department official said on Wednesday while confirming the first such fatality in the state.

As many as 14 other patients are suspected to have died of the infection in the state, which has so far reported 29 cases of the virus that causes fever, with symptoms similar to flu, and acute encephalitis (inflammation of the brain). "The sample of a four-year-old girl from Aravalli district's Mota Kanthariya village, who died at the civil hospital at Himatnagar in Sabarkantha district, has tested positive for the Chandipura virus. This was the first death due to the Chandipura virus infection in the state," the news agency PTI quoted

Sabarkantha Chief District Health Officer (CDHO) Raj Sutariya as saying. A patient from Rajasthan's Udaipur, who was being treated at a state hospital,



has also died of suspected Chandipura virus. The suspected deaths have been reported from Sabarkantha (two), Aravalli (two), Mahisagar (one), Mehsana (one), Rajkot (two),

Surendranagar (one), Ahmedabad (one), Morbi (two) and GMC (one) districts. he cases have also been reported from Kheda, Gandhinagar, Panchmahaland Jamnagar districts. Another patient from Rajasthan's Udaipur and one from Madhya Pradesh's Dhar have also been treated in the state hospitals, officials said. What Is Chandipura Virus Chandipura virus is a type of arbovirus that is a member of the vesicular virus genus of the Rhabdoviridae family. It is transmitted primarily through phlebotomine sandflies and sometimes through ticks and mosquitoes. Children are reportedly more prone to getting infected with this virus. It was first identified in India in 1965 in Chandipura village in Maharashtra.

Railway Cops Rescued Over 84,000 Children Under Risk In Stations, Trains In Last 7 Years

New Delhi: The Railway Protection Force (RPF) has rescued as many as 84,119 children who were at risk in stations and trains across the country during the last seven years (2018-2024), preventing them from falling into harm's way, according to data released by the Ministry of Railways on Wednesday. Most of these children had run away from home or were reported missing while some had been left behind at railway stations or trains. There were also some children among them who had been kidnapped.

In the first five months of 2024, the RPF has already rescued 4,607 children. With 3430 runaway children rescued, the early trends suggest a continued commitment to the operation 'Nanhe Faristey'. The numbers reflect both the persistent issues of child runaways and the dedicated efforts of the RPF to address them. The RPF's 'Nanhe Faristey' mission dedicated to rescuing children in need of care and protection across various Indian Railway Zones has turned out to be a lifeline for thousands of children who find themselves in precarious situations.

The year 2018 marked a significant start for 'Operation Nanhe Faristey' with the RPF rescuing a total of 17,112 children, including both boys and girls. Out of 17,112 children rescued, 13,187 were identified as runaway children, an alarming number of 2,105 were found to be missing, 1091 children as left behind, 400 as destitute, 87 as kidnapped, 78 as mentally challenged and 131 as street children. During 2019, the RPF's efforts continued to bear fruit, with a total of 15,932 children, including both boys and girls being rescued. Out of 15,932 children rescued, 12,708 as runaway children, 1454 as missing, 1036 children as left behind, 350 as destitute, 56 as kidnapped, 123 as mentally challenged and 171 as street children. The consistent numbers showcased the persistent issue of children running away and needing protection.

The year 2020 was challenging due to the COVID-19 pandemic, which disrupted normal life and significantly impacted operations. Despite these challenges, the RPF managed to rescue 5,011 children. During 2021, there was a resurgence in the RPF's rescue operations with 11,907 children being rescued during the year. There was a significant increase in the number of children found and protected, with 9601 children identified as runaways, 961 as missing, 648 as left behind, 370 as destitute, 78 as kidnapped, 82 as mentally challenged and 123 as street children.

New Delhi: A woman shared her shocking experience while visiting a cafe in Bengaluru. The cafe served authentic South Indian dishes like dosa, idli, vada, kesari bhath, chow chow bhath, and much more at an unbelievable price. The post of a woman went viral on the internet, sending shock waves among netizens. The woman (Sahili) went to Taaza Thindi restaurant in Jayanagar, Bengaluru craving a South Indian dish and was hit by surprise looking at the menu pricing. The food card rated idli at rupees 10, masala dosa at 20, vada at 10, and kesari bhath at rupees 12.

also shared a picture of the two dosas, idli, and vada including two drinks that she ordered from the restaurant. The post went viral on the internet with



Posting the menu Sahili compared it with Rameshwaram cafe of Bengaluru which is famous for its South Indian cuisine and wrote, "What is the Rameshwaram are these prices." She

over 50,000 views, 5000 likes, and 250 comments. Prices on the menu have shocked internet users and are flooding the comment section with various reactions. "You guys are so lucky the

price is insane. In goa we get overpriced South Indian Food in so-called new age QSR outlets. Dosa is 120-150 rupees and tastes like crap." said one. Another joined with, "Kolkata, wakes up to idli at 55/- per piece in south indian restaurants. Third individual shares his emotions on the post and wrote, "Wow! This what I used to pay 15 years back in Mumbai. Wish they came with this pricing or even marginally higher in Mumbai!" Fourth user commented, "This is dirt cheap, in ncr non restaurants like Haldiram's sell Masala dosa for approximately 250.

Fifth user added, "All Thindis in jp nagar jayanagar Malleswaram area are cost effective and taste way better than overrated Rameshwaram and Filter coffee."

"I'm A Nepo Kid," Admits Chirag Paswan, But Calls It "Double-Edged Sword"
